Welcome

The meeting convened at 10:15 am. Quorum was established.

1. Ethics Statement

The Ethics Statement was read to members by Chairperson Anita Blair.

2. Approval of Agenda (Approved)

A motion was made by Scott Efird to approve the agenda. It was seconded by Bjorn Hansen and unanimously approved.

3. Approval of Minutes from March 2022 (Approved)

A motion was made by Bridget Helms to approve the minutes. It was seconded by Scott Efird and unanimously approved.

4. FY23 PWP Final (Approved)

Lee Snuggs, RRRPO

The members were presented the RRRPO FY23 PWP Final for the 2023 funding. A motion was made by Scott Efird to approve the FY23 PWP Final as presented. It was seconded by Bridget Helms and unanimously approved.

5. NCDOT Intersection Safety Analysis: Understanding the Data.....(INFORMATION) Pate Butler, NCDOT

The presentation 'NCDOT Intersection Safety Analysis: Understanding the Data' was presented to members and guests. The purpose and 2022 overview of the 'Highway Safety Improvement Program' was presented and discussed. Local intersection reports were shared, as well as, data used to determine the best route to use, traffic signal, all way stop or roundabout for intersections. Ms. Butler fielded many questions from members and guests.

6. Transit Providers:

- a. SCUSA: Randy Shank
 - Business as usual, ridership is gradually increasing, Covid mask mandates are ended.
 - Having difficulty getting new vehicles. Three were ordered in August of 2021, delivery date is still undetermined.

b. UCT: Bjorn Hansen

• At our March meeting, Union County was kicking off a study of whether to keep or replace our express bus service from Monroe/ Indian Trail to uptown Charlotte. Express bus ridership has tanked due to Covid and was already declining pre-Covid. We are about to be in our public comment period which will go for about a month. Decisions from the stakeholders committee are hopeful by early fall. Once those are recieved, the decision will go before our TAB and County Commissioners before the end of the year as to whether to keep the service or replace it.

7. NCDOT Updates:

- a. County: Division Staff
- NC 24/27 Widening Project (R-2530B) The widening of NC 24/27 from Albemarle to Lake Tillery. Work is underway on the project with utility crews making good progress. Currently working on grading, sewer line work, culvert construction, storm drains, and temporary walls. Project is currently shown as being 60% complete. It is scheduled to be complete at the end of 2023.
- Bethany Road Bridge Replacement in Albemarle The contractor has defaulted and NCDOT has terminated his contract. The bonding company will now select another contractor to complete the bridge replacement. Work has been stopped on the project until the bonding company selects another contractor to complete the project. We are still awaiting the bonding company to work through the legalities and hire another contractor to complete the project. A revised completion date will not be available until a new contractor is selected and able to begin work.
- NC 218 Rumble Strip Project NCDOT awarded a contract in April to install rumble strips and new thermoplastic pavement markings along a 30 mile stretch of NC 218 at select locations

in Mecklenburg, Union, and Anson Counties. The project will end at the Polkton City Limits. The contractor is expected to begin work later this month with completion expected in late July.

b. Mobility & Safety Division: Regional Traffic Staff

• Lee and I will be making our visits to all jurisdictions in the RRRPO this fall to discuss any municipal needs/concerns for area roadways.

d. Transportation Planning Division: Roger Castillo

- Anson County CTP Steering Committee met last month to go over introductions and discussed scope of CTP and what it will cover. Next meeting will be focused on goals and objectives and introducing the upcoming survey for Anson County citizens. A link is located in chat for Anson County CTP documents and updates.
- As part of the Executive Order #246, NCDOT is tasked with developing a clean transportation plan. On April 1, 2022, a public information meeting was held with stakeholders to outline the near term strategies NC needs to reduce greenhouse gas emissions, increase use of zero emission vehicles and other improvements. A survey link is available in chat to share your thoughts.

• Lee Snuggs, Scott Miller and Stuart Basham have been working on the proposed draft STIP list that has just been released. Lee has condensed the list for our RPO area and each jurisdiction's projects will be discussed in visits this fall by Lee and Scott.

Bjorn Hansen suggested that 'Public Comment' would be better served at the beginning of the
meeting instead of where it is now located at the end. This was discussed amongst the board
members and Michael Sandy made the motion to move it to the beginning of the agenda. It was
