7. Stanfield Sidewalk Project Update.....(INFORMATION)

An in-person meeting between Stanfield, Locust, RRRPO and NCDOT/Div. 10 was held to look at concerns with areas along the west side of the corridor. Looking at a new route along this corridor, it was determined by all parties that more homes/people would benefit with the revised route. Division 10 will develop new estimates for crossing at the new point and present them to the Stanfield Board of Commissioners at their May meeting. If they approve of the new crossing and cost estimate, additional funds can be sought since the project has gone through the STIP process. Additional funds are also being researched to supplement Stanfield with their required monetary contribution for the project, being that the project has been extremely delayed, at no fault to either party.

8. CMAQ Funds Swap.....(INFORMATION)

Possible projects for the CMAQ Funds Swap were presented and discussed: Roundabout in Misenheimer #52/Pfeiffer University, Gray Stone Day School; Roundabout in Badin at Falls Road/#740; Realignment at #52/Plank Road in Ansonville. Vote of final projects will occur at the RRRPO's May meeting.

9. Metrolina CommunityViz Data & Model Presentation/Draft Statement of Work(SOW) Contract.....(INFORMATION)

The objective of this project is to update the 2019 Metrolina Region CommunityViz Model and use it immediately for the Rocky River Rural Planning Organization (RRRPO) planning area represented in the 2055 Metrolina Regional Travel Demand Model. Specifically, our work will focus on updating the 2019 Metrolina CommunityViz data and model created for the 2050 Metrolina Regional Travel Demand Model, and associated land use data, to allocate future socioeconomic data at the traffic analysis zone level. At the completion of the project, Centralina Regional Council will provide the file structure and GIS data files used to create the Metrolina CommunityViz Model to RRRPO and its member jurisdictions for independent use. A final vote will be taken at our May meeting.

10. Transit Providers:

a. ACT: Tanya Byrd

- In the process of building a new facility on the recently purchased Pee Dee Electric property. ACTS is temporarily housed at the old Pee Dee Electric building.

11. NCDOT Updates:

a. County: Division Staff

- **NC 24/27 Widening Project (R-2530B)** – Project is approximately 76% complete. Current operations include earthwork, drainage, culvert construction and wet utility installation. Indian Mound Rd and Stony Gap have re-opened to traffic. According to Contractor, project status is scheduled to meet 7/1/23 completion date; however, the Department expects work to continue after this date. The Department's expected completion is the end of 2023. Controlling operation is wet utility relocations.
- **Old Cottonville Road Emergency Bridge Closure (DJ00246)** –Working is ongoing and the bridge is expected to be opened to traffic in May 2023.
- **Millington Road Bridge Replacement (DJ00390)** – Construction will begin in mid-April 2023. The bridge is over Long Creek near Richfield.
- **City Pond Road Bridge Replacement (B-5809)** – Bridge is complete. Contractors are working on grading the project. Paving should begin soon. Project should be completed except for vegetation establishment in April.
- **US 52 Bridge Replacement over Rocky River (B-4407)** – Traffic has been placed on

b. Mobility & Safety Division:Regional Traffic Staff

- Several projects submitted for rumble strips in Anson & Stanly counties. Once funded 6 inch rumble strips will be installed on roadway edges, as well as the center line.
